



1040 Movie Screening

Contact 1040movie@adventures.tv for an initial intake form! We are more than happy to walk you through the steps and work side by side with you and your community to make a screening possible!

AGREED GUIDELINES:

- Church agrees not to reproduce copy or retransmit *1040* without the express written consent of ADVENTURES.TV
- Church agrees to return *1040* DVD to ADVENTURES.TV within 5 business days of final showing.
- Church agrees to allow a designated *1040* Representative to speak either before and/or after the screening.
- Church agrees to a \$750 screening fee, which is often used to cover travel of the *1040* Representative. Please contact us at 1040movie@adventures.tv if this is not possible for your ministry or organization—we will work to make it possible!
- Church agrees to not sell tickets or charge admission for the screening unless previously discussed with *1040* Screening Team.
- Church agrees to collect a love donation for every showing.
- Church agrees to pay to ADVENTURES.TV the 50% of gross donations within 5 business days of final showing. Gross donations means money collected from donations to Church for viewing of *1040*.
- Church agrees to provide a table and allow a *1040* Representative to sell *1040* DVDs and/or all relevant merchandise.
- Jaeson Ma is also available to speak outside of the *1040* Screening, but must be booked through <http://jaesonma.com/contact/>

OTHER INFORMATION:

- *1040* runs 75 minutes long, DVD format, Blu-Ray available upon request.
- We will require a *1040* representative at the screening, costs will be addressed below.

COSTS:

- The screening does require a \$750 deposit, in addition to a 50% split of the gross donations from the love offering. Please note that the screening deposit should not be deducted from the *1040* Team's portion of the love offering, as it will directly feed into the *1040* ministry.
- If you would like to have Jaeson come and speak at the screening please contact Wendy Wong at wendy.wong@adventures.tv who handles Jaeson's speaking engagements separately. Otherwise, we highly encourage the presence of a *1040* representative at the screening. We also ask that they be provided with lodging and transportation to and from the venue.
- Please note that *1040* was not made for profit and the deposit will go towards the cost of production and travel expenses. We do not want the issue of money to detract from the greater message of *1040*. This film is much bigger than us and our team humbly recognizes that. If \$750 is too much of a stretch for your



organization, we can offer another option as well. Please contact 1040movie@adventures.tv for more information.

- International screenings, or screenings held outside the United States and Canada, are still required to pay the \$750 deposit in addition to the love offering. We also ask that your organization provide round-trip airfare, accommodation, and transportation for two members from our *1040* Team. If your screening coincides with a date in which one of our representatives is in your area we will simply require the \$750 deposit.

In terms of financial issues and costs, we've been able to test out several models and these are the ones that seem to be most flexible and supportive for ministries:

FREE SCREENINGS:

- We highly encourage organizations to hold a free screening and not charge any entrance fees. The original model of \$750 deposit and the 50% of gross donations/love offering would remain consistent. Our team finds that you are likely to draw in a larger audience and those in attendance are more likely to give generously.

OTHER ALTERNATIVE:

- After the \$750 screening deposit, you may decide that you want to charge an admission fee. What you want to charge is actually completely up to the organization. Any ticketing would have to be organized and managed by the hosting organization, however. If you did want to do a ticketing system, we normally request 50% or a fixed cost of any ticket sales; while we would contribute 20% of our own merchandise revenue to your organization. Any love offering taken would also be split in half between the hosting organization and the *1040* Team.

Deposit must be received at least two weeks before the event. Checks should be written out to "**Adventures Corps LLC**". Wiring information is also available upon request. International venues should wire or send a cashier's check.
